



MEMORANDUM OF UNDERSTANDING

This Memorandum of understanding is entered into on this 14th September, 2021

Article 1

Purpose

Anuradha K Paranjape & Co. and *Department of commerce, Dapoli Urban Bank Senior Science College, Dapoli, Dist. Ratnagiri, Maharashtra* in the confident expectation has decided to agree to establish industry-academic collaboration in areas of mutual interest and in accordance with terms and conditions set forth in this Memorandum of Understanding (MOU),

- a. **First Party** may participate in campus placements program and will offer job facilities to the interested candidates of **Second Party**, from Technical Course of specified Streams, after completion of 3rd Year. The number of candidates, who can be considered for the Employment, would get the offer letter in written version after mutually decided between both the Parties herein.
- b. **First Party** will arrange training program before employment, so that selected candidates will get practical exposure and learning from interaction with project members of **First Party**.
3. **First Party** will offer internship to interested candidates which will be organized after mutually decided between both the Parties herein.
4. The above said campus placement program as mentioned in Clause 1 will be arranged by the **Second Party** at the will of the **First Party** and provide interested candidates when required.

5. **First Party** may select the interested candidates of the **Second Party** directly without any prior campus placement program also. In that case **Second Party** will be informed in written version of such direct employment.

6. **First Party** may terminate the employment of any selected candidate any time after the selection process till joining/after joining, if reasonable cause found.

Article 2

Term And Extension:

This Agreement will be effective from the day of its signing by both Parties. It will be valid throughout Lifetime until and unless anyone of the Parties want to break by showing any valuable reason. The Parties agree that no person is excluded from participation under the terms of this Agreement on the grounds of race, colour, national origin, sex, creed, or other ground protected by and in accordance with applicable law.

Article 3

Assignability:

The respective Rights and Obligations of the Parties under this Agreement shall not be assignable.

Article 4

Governing Law:

This Agreement shall be governed by, and constructed in accordance with, the Law of the State of Maharashtra. Any dispute between the parties concerning this Agreement shall be brought in the Courts of Maharashtra.

Article 5

Modification:

This Agreement constitutes the entire understanding of the Parties with respect to the Relationship and may be modified only by a written agreement signed by each Party.
